

## **GUIDE TO PREPARING FOR FERMUN 2024**

Please read the guide below, which will help you better understand how to prepare a MUN at the ILO.

## Distribution of delegations:

in the framework of a tripartite conference, for the same country, delegates will represent:

- the government
- employers
- workers

Schools are therefore allocated positions for workers', employers' and government representatives: 3 positions for a single country.

A school may have an employers' representative, a workers' representative and a government representative for the same country. Sometimes, a school will have only government positions or only worker/employer positions, due to arithmetical constraints.

## **Research work for the students:**

The research work for the government position is similar to a classic MUN (country research). Countries present either an individual position or a position by regional group. Students' research should start with the ILO website, where they will find a wealth of information by country, theme or sector. Then they can go to the website of the Ministry of Labor in the country they represent.

For employers and workers, it's important to understand that the work will consist of seeking a consensus between workers and employers, and then discussing with governments. This is the introduction of social dialogue into MUNs. Dialogue and the search for common positions among the social partners (workers and employers), followed by dialogue with governments.
